Bridal - \$160.00  
Bridesmaid - \$140.00  
Additional Guest - \$140.00

Flower girl (12-16) - \$80.00  
Flower girl (U12) - \$0.00

Bridal Trial - \$140.00  
Bridesmaid - \$140.00  
Mother of Bride - \$110.00

## ADDITIONAL INFORMATION

A **minimum of 4** per party is required & a maximum of 6 to 7\*

A non-refundable deposit of \$115.00 is required to secure the booking.  
This will be deducted from the final invoice. The remaining balance must  
be paid prior to the wedding date.

### **Out of town Travel:**

Road Fee: \$50/per hour  
Accommodation per night: \$200.00

### **Flights:**

If flights are required, I will arrange them as needed, and the cost  
will be billed to the client. Flight pricing may vary based on airline policies,  
and all details will be confirmed and finalised during our consultation

# TERMS & CONDITIONS

---

## 1. Booking and Deposit

- A non-refundable deposit of \$115.00 is required to secure the wedding date. The deposit will be deducted from the total amount due.
- No booking is confirmed until the deposit payment has been made
- The remaining balance is due at least a week prior to the wedding date.

## 2. Cancellations

- If the Client cancels the booking, the deposit will not be refunded.
- If Annalee cancels due to unforeseen circumstances (e.g., illness, emergencies), all efforts will be made to find a replacement artist. If no replacement is found, the deposit will be refunded.
- Cancellations made less than 30 days prior to the wedding will result in full payment being due.

## 3. Number of Clients

- A minimum of 4 clients per bridal party as to be confirmed for a secured booking, with maximum of 7\* (dependant of ceremony/first look time).

## 4. Start and Finish Time

- The start and finish times for makeup services will be agreed upon in advance via a confirmed run sheet from Annalee.

## 5. Trials

- Bridal makeup trials are recommended and are scheduled separately from the wedding day. The cost of the trial is \$140.00 and payable in the final invoicing. I recommend getting in touch at least 3-4 months out from when you'd like to book this to save missing out on a preferred date. Most Fridays & Saturdays will be unavailable from Oct- April due to peak wedding season.
- Trials do not guarantee the wedding day booking; a deposit must still be paid to secure the wedding date.

## 7. Health and Safety

- The Client must inform Annalee of any allergies, skin conditions, or sensitivities prior to the service.
- Annalee will take every precaution to ensure products used are suitable for the Client, but will not be liable for any allergic reactions or complications arising from failure to inform Annalee about pre-existing conditions.

## 8. Photography and Promotion

- Annalee reserves the right to use photographs taken of the Client or bridal party for promotional purposes, including social media, websites, and portfolios, unless the Client requests otherwise in writing.

## 9. Liability

- Annalee is not responsible for any damage to makeup after application is completed.
- Annalee will not be held liable for any injuries, illnesses, losses, or damages associated with the services provided.

## 10. Force Majeure

- In the event of unforeseen circumstances beyond Annalee's control (e.g., natural disasters, extreme weather, pandemics), Annalee reserves the right to cancel or reschedule services. The Client will be offered a full refund of the deposit in such cases.

## 11. Payment Terms

- The final payment must be made in full prior to the wedding day.
- If the final balance is not paid by the due date, Annalee reserves the right to cancel services and retain the deposit.
